

MEMO OF AGREEMENT, made this :29th day of November 1989

Between: André Norton

c/o Vega Agentur - Brunnenstrasse 7/4 - D 7259 Frolzheim - Germania Federale
(hereinafter called the Proprietor) on the one part

and ARNOLDO MONDADORI EDITORE - Via Bianca di Savoia 12 - Milano - Italy
(hereinafter called the Publisher) on the other part

WHEREBY IT IS MUTUALLY AGREED as follows regarding the work (hereinafter called "The said work") entitled:

OPERATION TIME SEARCH

- 1) THE PROPRIETOR grants the Publisher the license to publish said word in the Italian language in the series called URANIA
- 2) THE PUBLISHERS shall pay the Proprietor the sum of Italian lire 5,000,000 (five million lire) for one publication only (half of which on the signature of the contract and the other half on publication or within 12 month from the date of the signature, whichever date is earlier).
- 3) ROYALTIES: Not applicable
- 4) ALL MONIES DUE herunder shall be payable to the Proprietor or the Proprietor's agents through

D 7259 FROLZHEIM, Germania Federale**
- it is being understood and agreed that this license shall be considered in effect when the Publishers are in possession of the official receipt of the Proprietor and his/her authorized agents.
- 5) IF THE PUBLISHERS fail to issue their edition of the said work within 24 months of the date of this agreement, the right herein licensed shall revert to the Proprietor at once without further notice, and any advance payment made by the Publisher under the terms of this agreement shall be forfeited without prejudice to any further claim which the Proprietor may have for damages and/or otherwise.
- 6) THE ABOVE CONDITIONS cover a circulation of 35,000 copies minimum. Publication price is:4,000 lire. Pro-rata supplement provided for exceeding copies. Publication price:4,000 lire.
- 7) IF AT ANY TIME, after the date of first publication of the Italian translation, the publishers shall allow the said work to go out of print or off the market and to remain out of print or off the market for six months running or if after three years from publication of the translation less than 100 copies are sold per year, all rights licensed to the Publishers herein shall revert to the Proprietor at once and without further notice, without prejudice to any monies already paid and then due.(NOT APPLICABLE)
- 8) CONTRACT TERMINATION: at the end of FIVE years dated from this agreement, the rights herein shall revert to the Proprietor.
- 9) THE TRANSLATION of the said work shall be made faithfully and accurately and abbreviations, additions or alterations in the text thereof shall be made only with the written consent of the Proprietor and his/her agents.
- 10) THE PUBLISHERS undertake that the name of the author shall appear in due prominence on the title page and binding. Copyright and title, as they appear in the original edition, shall appear beneath the title or on the back of the title page of every copy of the publishers' edition. Six (6) gratis copies of the said work shall be sent to the publishers to

VEGA AGENTUR and 1 to ANTONIO BELLONI, Via Tolmezzo 5/1, 20132 MILANO

- 11) IN THE EVENT of the Publishers becoming bankrupt or violating any clause of this agreement, other than clause 5 or 7, the agreement shall become automatically null and void, and the license granted to the Publishers shall revert at once to the Proprietor without prejudice to the Proprietor's right of recovery of any sums due to him/her.
- 12) IT IS EXPRESSLY understood and agreed that this license carries with it no other rights or privileges and that all rights not specifically granted herein are reserved exclusively to the Proprietor, and that the license herein granted is assigned to the Publishers solely and shall not be transferred by them without the written consent of the Proprietor and/or his/her agents.
