If you incorporate any copyrighted material in the Work, you shall procure and deliver to us, simultaneously with the delivery of this contract, signed written permission from the copyright owner to reprint such material. Said permission shall be obtained at your expense. You agree to hold the Magazine and its licensees and assigns harmless against any claims or suits (including costs, expenses, and reasonable attorney's fees) arising out of any breach of your warranties or agreements hereunder.
 - In consideration of our payment to you of the sum set forth above, you grant us or our successors and assigns first English language world-wide publishing rights in the Work. You agree not to authorize any other publication of the Work without the consent of the Magazine before three months have elapsed from the date of our publication of the Work and agree that in any future use of the Work in print, you will arrange that a credit be given to Marion Zimmer Bradley's Fantasy Magazine as the magazine of original publication.
 - You grant Marion Zimmer Bradley's Fantasy Magazine the right 4. to illustrate the Work, change its title, and to condense and edit the Work in a manner consistent with the editorial standards of the Magazine. When time permits, the Magazine will consult with you regarding such aditorial changes.
 - You authorize the Magazine to use the Work, your name, your biography, and your likeness in connection with the Work, and in our advertising and promotion.

6. a. When signed by all parties hereto, this agreement shall be effective as of the date indicated below. For the purposes of this agreement, the term "you" shall apply both in the singular and, in the case of a collaboration, in the plural. In the case of a work of joint authorship, each author shall be jointly and severally liable for the warranties and agreements contained herein. Unless paid to an agent, payments shall be evenly divided among all joint authors by the Magazine unless otherwise specified in writing.

This agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, executors, administrators, successors and assigns.

This agreement is governed by the laws of California and the United States and can only be changed by an agreement in writing, signed by all of the parties hereto.
